



# **UPR INFO PRE-SESSIONS 44**

UPR Info is organising the Pre-sessions 44 to the Universal Periodic Review the week of 28<sup>th</sup> August to 1<sup>st</sup> September 2023, which will take place in person, in Geneva. These meetings are organized in advance of the 44<sup>th</sup> UPR Working Group and will include sessions on the following countries: <u>Turkmenistan</u>, <u>Burkina Faso</u>, <u>Republic of Cabo Verde</u>, <u>Colombia</u>, <u>Republic of Uzbekistan</u>, <u>Tuvalu</u>, <u>Federal Republic of Germany</u>, <u>Republic of Djibouti</u>, <u>Canada</u>, <u>People's Republic of Bangladesh</u>, <u>Russian Federation</u>, <u>Republic of Azerbaijan</u>, <u>Republic of Cameroon</u>, Republic of Cuba.

Thanks to the generous support of our donors, UPR Info will offer a travel grant to some successful applicants. Civil society organisations (CSOs) from the following countries can apply for a grant: Republic of Cameroon, Republic of Djibouti, People's Republic of Bangladesh, Republic of Cabo Verde, Republic of Uzbekistan, Tuvalu. The grant includes accommodation, airfare and per diems for up to 6 days in Geneva. To apply for the grant, please fill out one of the following forms: Republic of Cameroon, Republic of Djibouti, People's Republic of Bangladesh, Republic of Cabo Verde, Republic of Uzbekistan, Tuvalu. Due to limited financial resources, not all applicants who apply for a grant can be selected to receive this grant. For organisations that do not require a grant, please apply via the normal link.

#### **OBJECTIVES**

The purpose of the Pre-sessions is to offer Civil Society Organisations (CSOs) and National Human Rights Institutions (NHRIs) an opportunity to brief permanent delegations on the human rights situation in the States under review. They provide space for civil society to engage directly in a dialogue with States, ensuring that their suggestions and recommendations are taken into consideration by recommending States in advance of the Working Group.

## **FORMAT**

The Pre-sessions 44 will take place before the 44<sup>th</sup> Universal Periodic Review Working Group, which is scheduled to take place from 6<sup>th</sup> to 17<sup>th</sup> November 2023. CSOs and NHRIs will be invited to present their assessment of the human rights situation in the country since the previous review **and will participate in a question-and-answer session** with recommending States following the presentation of the statements. With the principles of **transparency and universality** in mind, all Permanent Missions are invited, including the State under review.

### **EXPECTED OUTCOMES**

The Pre-sessions will offer an exchange of information on the human rights situation of the forthcoming State under review. States will receive up-to-date information and recommendations in advance of the 44<sup>th</sup> UPR Working Group session. Recommending States will also have the opportunity to ask questions to NHRI and civil society representatives to gain insights into the situation on the ground from a first-hand perspective. The information given will reflect the reality of the human rights situation in the State under review and will represent the concerns of all stakeholders on the ground.





#### WHAT TO EXPECT

The Pre-sessions are a **forum for collaboration and information sharing**. The meetings fill an expressed need from both State delegations and CSOs to meet prior to the UPR Working Group session to identify, discuss, and further develop recommendations to ensure focused attention to the most relevant human rights issues during the review.

The application process to speak at the Pre-sessions will be opened on UPR Info's website <a href="www.upr-info.org">www.upr-info.org</a> until 31 May 2023. Applicants are required to fill out the online application form available <a href="here">here</a>, providing information on their engagement in the promotion of human rights.
